4. Disconnect Bill if applying for Utility Assistance.
5. Notice to Vacate/Eviction if applying for Rental Assistance.
6. Complete copy of current Lease Agreement.

The Harris County Veterans Services Office is responsible for certifying Veterans character of discharge. Applications are processed through the Case Management, Office of Social Services, and Community Services Department.

Please allow 5 to 7 business days for an Eligibility Specialist to contact you to conduct a screening.
